



## SSCP Face to Face Training

### Multi-Agency Sexual Health in the Community

You are invited to attend multi-agency sexual health training. At the session you will find out about the various forms of contraception, STIs and how to prevent them and where services are in Salford and how you can access them. Under 18 conceptions in Salford have risen since the COVID pandemic and Salford has the highest teenage pregnancy rate in Greater Manchester. Sexually transmitted infections (STIs) are on the rise too. Young people who are the most vulnerable are more likely to become pregnant and go on to a pregnancy or abortion.

**Target Audience:** youth workers, early help workers, social workers, school nurses, pathway advisers, pastoral staff at college and school, Route 29 staff, Youth Justice, Missing from Home, Connect and Stepping stones teams

**Aim of the training:** To empower **non-healthcare professionals** with the confidence to initiate sensitive, inclusive and factual conversations about sexual health, and to signpost and support people to access local sexual health services

**By the end of the training, participants will be able to:**

- Understand the importance and characteristics of a sex positive and inclusive approach to sexual health.
- Feel confident to talk about a range of contraceptive methods with young people and signpost them to appropriate services.
- Tell young people about the most common STIs, their symptoms, testing and treatment, signpost to services, and counter common myths and challenge STI stigma.
- Explain the benefits of barrier methods, tell young people about condom distribution schemes and carry out a condom demonstration.
- Recognise important safeguarding issues related to young people's sexual health and wellbeing and be able to take a multiagency approach to keeping young people safe.

There will be local resources to take away.

## **CHARGING POLICY**

**From 1<sup>st</sup> April 2023 the SSCP re-introduced the non-attendance charging policy.
