## Welcome to the GMYCA

#### About the GMYCA

The <u>GMYCA/YCA</u> is made up of young people aged 11-18 years of age representing projects or organisations. For 2024-2026, there are 29 member organisations, each with two representatives.

The GMYCA was formed in 2018 and is an integral part of the Greater Manchester Combined Authority and the Mayor's Office. The purpose of the GMYCA is to:

- Advise the Mayor and Greater Manchester Combined Authority (GMCA) on key issues and concerns of young people, and provide solutions;
- Provide a critical voice and scrutinise the work of the Mayor and GMCA;
- Undertake specific pieces of work, e.g. develop the Opportunity Pass, Curriculum for Life, etc.


#### What to expect from the YCA:

- The GMYCA meets as a full group once a month every second Thursday of the month 6-8pm in the centre of Manchester.
- Refreshments will be provided please ensure that any dietary needs and allergies are added to the consent forms as well as any additional and or accessibility needs.
- We have two development days each year and they are to team build, work on skills and have fun. The workers have up to three meetings a year.

# **Key Information**

#### Representatives

All representatives and their parents/guardians must complete the online consent form <u>(click here to access)</u> in order to take part in GMYCA meetings and other activities.

Workers and young people must also read and sign the code of conduct together, which will be available to sign at the first YCA meeting (and will be shared in advance). This must be signed for every representative (and deputies where applicable).

### Workers

Each organisation will be invited to meet with YFNW before the start of the term for an induction chat, and to ask any questions you may have.

Each organisation can choose/elect up to two representatives to attend meetings (you may also wish to have two deputies as well, but you will only be able to have two representatives attend each meeting at any one time).

Any changes to representatives must be shared with YFNW at the earliest convenience, and any new representatives must have a consent form and code of conduct completed before attending any meetings.

Travel Expenses can be reimbursed; please ask YFNW for a claim form.

### **KEEPING YOU SAFE AT OUR SESSIONS** What you can expect from us:



Before you come to a session (both online and in person), you'll be sent information about who the Youth Worker from YFNW is, where the session will be, and any other details you may need.



At the start of each session we will let you know where the fire exits and bathrooms are, and any other safety information you will need.



There will be a quiet space available away from the main session, in case you need some time out.



We will create safe spaces for you to form and share your views, we will treat you with respect and dignity.



We want everyone to be safe during sessions. We will respond to any concerns relating to your safety and wellbeing, and provide support and guidance when it's needed.



We will support you to share your personal experiences in a way that you are comfortable with. This is on your terms, and you can decide if and what you wish to share and with whom.



We will challenge any attitudes or behaviours that do not meet our expectations of staff, volunteers, visitors or young people.



We will maintain confidentiality, unless we need to share your information to protect you or someone else (if any action is needed, we will always communicate this with you where possible).

### **KEEPING YOU SAFE AT OUR SESSIONS** What we expect from you:



Make sure you complete your consent form online before attending a session. Ask a YFNW worker if you're not sure whether you've done it.



Please understand the importance of personal privacy and respect other's rights to confidentiality where required. We will follow up on any concerns raised in line with our safeguarding policy and to keep you safe.



When you are representing an organisation in sessions or externally remember how your actions and behaviour portray the organisation to others.



We encourage you to play your part in making everyone feel welcome. Treat others with respect and kindness. Be supportive of others and their lived experience. We have a zero tolerance of bullying in any form.



Do your best to be on time and come prepared to participate in as much of the activities as possible and be ready to embrace new ideas.



Respect other people's boundaries and be considerate in your interactions with others.


