



Working Together to Safeguard Children

1 Day Face to Face Training Level 2

In response to participant feedback, the SSCP are moving towards a hybrid model of training delivery providing both online and face to face courses as part of our training programme. The Working Together course is a pre-requisite to access any SSCP Level 3 enhanced and topic specific training.

Who should attend?

Members of the workforce with regular, co-ordinated and targeted contact with children, young people and/or parents/carers. Any professional who may be in a position to identify concerns about possible abuse or neglect, including those that may arise from the use of early help assessments and multi-agency support.

Course aims: To increase skills and confidence in interagency working to safeguard and promote the welfare of children

Learning Objectives:

- To understand that each agency has a responsibility towards a common goal, and to reflect on the role you play in safeguarding children.
- To increase knowledge and understanding of legislation, policy, and procedures for safeguarding children
- To know how to request support and make a referral in line with Salford Support and Safeguarding guidance
- To recognise when a child is at risk of harm, considering the impact on the child and how best to respond
- To ensure a holistic strength-based approach when working with families using effective assessment tools and resources
- To understand the importance of accurate and effective recording giving consideration to information sharing guidance

- To increase confidence in how to apply Salford's professional challenge and escalation policy
- To understand the impact of working with trauma has on practitioners and the importance of self-care, reflective practice, and supervision

In addition to the identified learning objectives, the following themes will be included throughout the course:

- Communication and engagement,
- The voice of the child and lived experience of the family
- Equality diversity and inclusion,
- Learning from practice reviews

It is recommended that following the Working Together training, those professionals who require a greater depth of safeguarding knowledge **must also attend** the Multi-Agency Guest Speaker training and any other additional relevant training.

When attending SSCP training delegates and managers have a responsibility to evidence impact on practice by:

- Completion of pre and post course evaluations
- Sharing learning back into their organisation
- Contributing to SSCPs ongoing commitment to measuring impact of training

CHARGING POLICY
